






### **GIFTS IN WILLS AT THE UNIVERSITY OF BRISTOL**

# LEGAL INFORMATION

### The details you need to include in your Will

- The University of Bristol will need to be named as a beneficiary in your Will
- Official University address:
   University of Bristol, Beacon House,
   Queens Road, Bristol BS8 1QU
- Exempt Charity Number X1121

Gifts in Wills are administered by the Planned Giving team (Global Engagement Division)

#### **Inheritance Tax**

If you leave charitable legacies in your Will you may be able to reduce the Inheritance Tax liability of your estate. As the University is an Exempt Charity, gifts to us can generally be free from Inheritance Tax. We recommend that you seek professional advice if you wish to minimise the tax burden on your estate.

#### Legal advice

Although we cannot offer legal or financial advice, we would be delighted to talk to you about what you would like your eventual gift to achieve. After that, we advise you to consult a solicitor before drafting your Will or updating an existing one. Do get in touch with us using the details below, for the attention of the Planned Giving team.

# TYPES OF LEGACY GIFTS

There are several ways that you can leave a legacy gift to the University. We are always happy to talk to you about the options to best achieve your ultimate wishes.



#### **RESIDUARY**

The whole or a specific portion or percentage of an estate left over after making other specified legacies (typically to family members, friends and other charitable causes). This type of legacy has the greatest value and impact as it is inflation proof.



#### **PECUNIARY**

The gift of a specific sum of money. It is possible to index link the sum of money in order to preserve its value despite inflation. Your solicitor will be able to advise you on which wording to use to achieve this.



#### **SPECIFIC**

The gift of a specific item which might be used by the University as it is (such as fine art or rare books). or which could be sold (property, land, shares, or financial products such as life insurances and pensions), with the proceeds supporting the University. We encourage you to speak to the Planned Giving team in the first instance if you are thinking of leaving specific items.

#### **REVERSIONARY**

A residuary, pecuniary or specific gift which is left to another beneficiary in the first instance, and which will revert to the University absolutely, usually after the initial beneficiary has died. This is a common type of gift that couples or parents consider, and your solicitor can advise on the benefits of setting this up.



#### **CONTINGENT**

A gift dependent upon the occurrence of an event which may or may not happen. For instance, a legacy which only applies if other beneficiaries named in the Will die before the person who made the Will.

# SAMPLE WILL WORDING

The following are examples of Will wording for guidance. Please ask your regional or international solicitor for advice on other geographical areas if you are outside England and Wales, and we recommend that you always consult your solicitor about Will wording. Do get in touch with us, and we can suggest bespoke sample wording for restricted legacies where you want to direct your gift to a specific project or purpose.

## Sample wording for an unrestricted legacy of a percentage of your residuary estate

I give... % of the residue of my estate (before the deduction of Inheritance Tax, if any is payable) to the University of Bristol, Beacon House, Queens Road, Bristol, BS8 1QU (Exempt Charity Number X1121) as an unrestricted legacy. It is my wish that it shall be applied for the benefit of said University wherever the University considers the funds could be best used at the time of their receipt. On realisation of the bequest a receipt from the Registrar or other authorised officer shall be sufficient discharge for my Executors.

## Sample wording for an unrestricted gift of a specific sum of money or specific item

I give [the sum of £...] [insert details of specific item] free of tax to the University of Bristol, [insert full address and Exempt Charity Number] as an unrestricted legacy. It is my wish... etc as before.





## Sample wording for a restricted legacy of a percentage of your residuary estate

I give... % of the residue of my estate (before the deduction of Inheritance Tax. if any is payable) to the University of Bristol, [insert full address and Exempt Charity Number] to support [insert specific project, direction or purpose of legacy]. If at my death this area is fully funded, or if it is no longer an area in which the University is actively involved, I wish that my gift is used to support activities that are as close as possible to my original intentions at the discretion of the University of Bristol. On realisation of the bequest a receipt from the Registrar or other authorised officer shall be sufficient discharge for my Executors.



I give [the sum of £...] [insert details of specific item] free of tax to the University of Bristol, [insert full address and charity number] to support [insert specific project, direction or purpose of legacy]. If at my death... etc as before.

#### In the case of a legacy of a fixed sum of money, you may wish to include the following

The legacy referred to in clause... shall be index-linked, so that the actual amount given shall be the figure which bears the same proportion to the sum stated as the index figure in the Retail Price Index (the 'Index') for the month in which my death occurs bears to the index figure in the Index for the month in which this Will is executed.

#### SUPPORTING **DISCOVERIES IN ARTS AND CULTURE**

'With the help of a beguest from Anthony John Edwards, who studied History at Bristol in the 1950s, the library was able to acquire a very special manuscript fragment, a leaf from the 'Glastonbury Bible' (pictured), probably written in nearby Glastonbury Abbey in the thirteenth century.

As the leaf shows, medieval scribes turned handwriting and book design into an art form. We are now using it to teach students on our MA in Medieval Studies how to read medieval manuscripts.'
