

Postgraduate Admissions Statement for

PhD Cellular and Molecular Medicine, MSc by Research Cellular and Molecular Medicine

This Admissions Statement applies to applications submitted for entry to the programme between 20 September 2023 and 15 September 2024.

Admissions criteria

Academic and English language requirements

Non-standard applications

We welcome applications from those with non-standard qualifications who can demonstrate knowledge, experience and skills developed in the workplace, or elsewhere, relevant to the programme of study. Please use your personal statement to provide further details.

Non-standard applications will be considered by the Admissions Tutor(s) for the programme on a case by case basis.

Application process

Online application form

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our <u>guidance for online applications page</u>

Applications will not be considered until **all** required documents have been uploaded.

Required and optional documents

References - Required

We require at least one academic reference. We would accept a reference from a Lead Supervisor/Principal Investigator of significant research experience, for example Year in Industry Supervisor. References should comply with our standard requirements outlined on <u>our guidance pages</u>.

Degree certificate(s) and academic transcripts - Required

From first and subsequent degrees. Degree certificates and transcripts should comply with our standard requirements outlined on <u>our guidance pages</u>.



Personal statement - Required

Personal statements should highlight the motivation for applying for the course, and any relevant experience and/or skills.

At the top of your personal statement, state your proposed area of research interest. Choose from:

Cancer Biology Infection and Immunology Stem Cell Research Other (please specify)

English language certificates/other evidence - Required

Evidence of meeting the English language profile as stated on the <u>Postgraduate Prospectus</u> and specified by the <u>University English Language Requirements Policy</u>

Curriculum Vitae (CV) - Required

CVs should include full details of academic credentials and might include other relevant work experience and qualifications to support an application.

Selection process

Assessment of applications

All applicants are considered in line with the University's <u>Admissions Principles and Procedures</u> <u>Policy</u> Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Performance in undergraduate degree and, if relevant, Masters degree
- English language ability (where applicable)
- References
- Personal statement
- Offers will typically be made in line with the academic requirements set out above.
- Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

Interviews

Interviews are part of the selection process as required.

The purpose of the interview is to assess whether the applicant has the necessary skills and capabilities to pursue the chosen postgraduate programme, and whether the programme is appropriate to the applicant's interests and aspirations.

If required, interviewees based overseas will normally be interviewed by telephone or Zoom.



Decisions

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

Offers

Deferrals

This programme does not normally allow deferrals unless there are exceptional circumstances. Please contact fls-pgenquiries@bristol.ac.uk if you would like to discuss the possibility of deferring your start date.

Results deadline

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions by 15 August for September 2023 entry. Offer holders who will be unable to provide their final results by this date should email fls-pgenquiries@bristol.ac.uk to notify the admissions team as soon as possible.

Extenuating circumstances

Academic Technology Approval Scheme (ATAS)
