# Postgraduate Admissions Statement for PhD Psychology



This Admissions Statement applies to applications submitted for entry to the programme between 1 October 2023 and 30 September 2024.

It should be read in association with the <u>University Admissions Principles and Procedures</u> for Postgraduate programmes, the relevant <u>prospectus entry</u> and general <u>application guidance</u>.

# **Academic and English language requirements**

## Non-standard applications

We welcome applications from those with non-standard qualifications who can demonstrate knowledge, experience and skills developed in the workplace, or elsewhere, relevant to the programme of study. Please use your personal statement to provide further details.

Non-standard applications will be considered by the Admissions Tutor(s) for the programme on a case by case basis.

# **Application process**

# Online application form

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our guidance for online applications page

Applications will not be considered until **all** required documents have been uploaded.

#### Required and optional documents

# **References: Required**

We require two academic references. References should comply with our standard requirements outlined on our guidance pages.

#### Degree certificate(s) and academic transcripts: Required

From first and subsequent degrees. Degree certificates and transcripts should comply with our standard requirements outlined on <u>our guidance pages</u>.

#### **Personal statement: Required**

Personal statements should not exceed one A4 page, highlight the motivation for applying for the course, and any relevant experience and/or skills. If appropriate, please also include any extenuating circumstances/leave of absence that may have impacted on your studies.

## English language certificates/other evidence: Required

Evidence of meeting the English language profile as stated on the <u>Postgraduate Prospectus</u> and specified by the <u>University English Language Requirements Policy</u>

#### Curriculum Vitae (CV): Required

CVs might include details of other relevant work experience and qualifications to support an application.

#### **Research Statement: Required**

You should use the research statement to define and situate your research within an academic/disciplinary context. With due regard for the primary audience/readership for postgraduate research (that is, the academic community), you should identify the following:

- 1. Proposed research topic (including potential supervisors if known please see: http://www.bristol.ac.uk/psychology/research/ for research interests of academic staff).
- 2. The research questions or problems that you intend to address 3. The research context for your project/programme of work
- 4. The methods you intend to use to pursue the key questions

You should also demonstrate how any previous research experience will benefit you in your chosen field.

• For the distance learning option only, the research statement should provide information about the external setting (facility/laboratory/environment) to undertake the proposed PhD [250 word limit].

#### **Distance Learning supporting letter: Required**

For the distance learning option only, applicants are also required to submit a supporting letter from any institution/organisation that they will depend upon for the purposes of completing their research.

#### **Research Training Statement: Optional**

If necessary, you should provide details of any training requirements to support your postgraduate studies.

# **Selection process**

#### Assessment of applications

All applicants are considered in line with the University's <u>Admissions Principles and Procedures Policy</u> Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Academic achievement
- English language proficiency (where applicable)
- Academic references
- personal statement

#### **Interviews**

Candidates may be invited to attend an interview. There is no set format for interviews, but they typically cover one or more of the following areas: the applicant's academic background, including training and experience that is of particular relevance to the programme or project; the applicant's motivation for applying, including specific research interests within the discipline and career aspirations; and potential research projects. Candidates will also have the opportunity to ask questions. Interviews are used to assess whether the applicant has the necessary skills and capabilities to pursue their chosen programme, and whether the programme is appropriate to their interests and aspirations. Interviewees based overseas are normally interviewed by telephone or online. Interviews are conducted by a minimum of two members of staff, at least one of whom is trained in fair and effective recruitment techniques. All interviews are undertaken in accordance with the University's Equality and Diversity Policy.

#### **Decisions**

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application system. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

#### Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

#### **Deferrals**

This programme does not normally allow deferrals unless there are exceptional circumstances. Please contact fls-pgenquiries@bristol.ac.uk if you would like to discuss the possibility of deferring your start date.

#### Results deadline

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions by 15 August for September 2023 entry.
