## **Admissions cycle**

This Admissions Statement applies to applications submitted for entry to the programme between 1st October 2018 and 30th September 2019.

## **Application deadline**

## **Admissions criteria**

#### **Academic requirements**

Applicants must hold/achieve a minimum of an upper second-class honours degree (or international equivalent) in psychology, or a closely related discipline (for example, neuroscience, clinical psychology). Applicants with previous professional experience or qualifications equivalent to the academic entry requirements are considered on a case-by-case basis.

For information on international equivalent qualifications, please refer to our International Office website.

## English language requirements for non-native English speakers

For applicants whose first language is not English, and whose full undergraduate degree was not taught in an English-speaking country, it is necessary to hold/achieve a minimum score in an approved English language test as specified in Profile C of the <u>University's English Language Requirements Policy</u>.

Applicants do not need to have reached the required level of English language before applying. If necessary, English language will be included as a condition of offer.

Applicants have the option to undertake one of the University's Pre-sessional English courses. You can find information about the University of Bristol's Pre-Sessional English courses at the <u>Centre for English Language</u> <u>and Foundation Studies website</u>.

#### Additional requirements

## **Application process**

#### **Online application form**

Applicants should complete the online application form, uploading all required documents directly into the application form. Guidance on uploading documents can be found in the <u>guidance for online applications</u>. Any paper documents received by post, or electronic documents received by email, will not be considered except in exceptional circumstances.

Applicants should make every effort to choose the correct programme in the application form by reading the prospectus entry and admissions statements fully. Applicants should <u>contact the relevant Admissions Team</u> if clarification is required.

#### **Documents required**

The required documents for this programme are listed below. Applications may not be considered until all required documents have been uploaded to the application form.

Applicants who have already submitted an application can upload additional documents into the 'Postsubmission uploads' section of the application form. Information about how to upload documents to an application form can be found in our <u>guidance for online applications</u>.

#### Required documents for this programme are:

• **Two academic references (minimum).** References should be submitted electronically by the referee, using the online reference form. Alternatively, scanned copies of the original reference document(s) can be uploaded by the applicant.

If you graduated more than two years ago, or if professional experience is relevant to your application, a professional reference will be accepted in lieu of one academic reference. At least one referee should be familiar with your academic work. References must be written, signed and dated on official letter-headed paper from the referee's organisation, and must include full referee contact details, as shown in the <u>reference template</u>. References supplied with a personal contact email address are only accepted in exceptional circumstances, which must be explained within the reference. All references must be dated within the last two years.

References for international candidates applying for the distance learning option should include a copy of the applicant's photograph, signed by the referee, to confirm their identity.

- **Degree certificate(s)** from first and subsequent degrees. We require colour scans of original documents and certified translations of documents issued in any language other than English.
- Academic transcripts from first and subsequent degrees. We require colour scans of original

documents and certified translations of documents issued in any language other than English. Transcripts must list all subjects taken and grades achieved to date, with the grade scale clearly displayed in the transcript. Applicants must clearly state their current average grade in the online application form.

- **Personal statement.** Applicants should highlight their motivation for undertaking this programme of study, together with any relevant experience that might enhance their application.
- English language certificates are required from applicants for whom English is not the native language and whose full undergraduate degree was not taught in an English-speaking country (please see the English Language Requirements for a list of English-speaking countries).
- **Curriculum Vitae (CV):** CVs might include details of other relevant work experience and qualifications to support an application. Please do not include any school (pre-university) certificates, unless otherwise specified above.
- Copy of current passport (for international students on the distance learning option).

#### **Correspondence with applicants**

Applicants will normally receive communication via email to the email address used to set up the application form account. Applicants should ensure the profile email address is kept up-to-date.

#### Selection process

#### **Assessment of applications**

All applicants are considered on an equal basis in line with the University's Equality and Diversity Policy.

Once a complete application has been submitted with all required supporting documents, it is considered by the admissions team using the following criteria:

- Academic achievement
- Academic references
- Personal statement
- Interview performance (where interviews are held)
- English language proficiency

Your performance in your first degree is generally the most important criterion, along with referees' statements regarding your potential to do well and develop as a scientist.

Where an applicant has undertaken a transnational education partnership programme or top-up degree, meeting the minimum academic entry criteria will not automatically mean an applicant will receive an offer. For these applicants, admissions decisions will consider the academic history of the applicant alongside relevance of degree, and, if required, degree content, and performance in key modules.

Each applicant is considered both holistically on their own merit and in competition with the rest of the applicant cohort during the academic cycle.

#### Interviews

Candidates may be invited for interview, and to visit the school and meet the supervisors.

The purpose of the interview is to assess whether the applicant currently has the necessary skills and capabilities to pursue the chosen postgraduate programme, and whether the programme is appropriate to the applicant's interests and aspirations.

If required, interviewees based overseas will normally be interviewed by telephone or Skype.

All interviews are conducted by two members of staff, at least one of whom is trained in fair and effective recruitment techniques. All interviews are undertaken in accordance with the University's policy on equal

#### opportunities.

## **Non-standard applications**

We welcome applications from those with non-standard qualifications who can demonstrate knowledge, experience and skills developed in the workplace, or elsewhere, relevant to the programme of study. Please use your personal statement to provide further details.

Non-standard applications will be considered by the Admissions Tutor(s) for the programme on a case by case basis.

## Decisions

## **Notification of decisions**

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission, this will be stated in the offer letter.

## Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to successful applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, successful applicants will receive a conditional offer outlining the requirements that must be met.

If an applicant is not selected to receive an offer for the course to which they have originally applied, we may offer the opportunity to be considered for an alternative programme in a related subject area. In such cases applicants will receive an email notification providing any alternative course options and asking whether they wish to be considered for these. It may be necessary for applicants to submit additional documentation in order for the application to be fully considered for an alternative programme. Details of the documentation required can be found in the <u>admissions statement</u> for the relevant programme.

## Deferrals

Deferred entry is available for this programme, subject to agreement by the relevant Admissions Team. Please contact the admissions team by emailing psychology-pg-admissions@bristol.ac.uk if you would like to request to defer your start date.

## **Additional information**

#### **Extenuating Circumstances**

If your education has been significantly disrupted through health or personal problems, disability or specific difficulties within your studies you can submit an <u>extenuating circumstances</u> form as part of your application.

The information provided on the form will be treated confidentially, and will help us to fairly assess your academic performance in light of your circumstances.

#### ATAS

An ATAS certificate is not required.

#### Deposits

International self-funded students accepting a place on a taught postgraduate programme are required to pay a deposit of £1500. Further information is available on <u>how to pay programme deposits</u>. Further information will also be provided in the offer letter to successful applicants.

The deposit is non-transferable and non-refundable except under the circumstances outlined in the International Deposits Refund Policy.

## Visa

International students coming to the UK to study full-time must apply for a student visa. <u>Tier 4 student visa</u> guidance notes are available on the University website.

## **Sponsored Students**

Sponsored students are not required to pay the deposit but will need to upload a copy of their sponsorship letter using the 'Post Submission Uploads' section of the online application. Sponsored students will also need to complete and upload the <u>sponsorship authorisation form</u>.
