Admissions criteria

Academic requirements

Applicants must hold/achieve a minimum of an upper second-class honours degree in psychology (or equivalent qualification) that confers Graduate Basis for Chartered Membership with the British Psychological Society. You should also have relevant experience of working with children or young people (aged 0-25). Applicants with a lower second-class degree (or international equivalent) and relevant experience may be considered.

English language requirements for non-native English speakers

Applicants whose first language is not English, and whose full undergraduate degree was not taught in an

English-speaking country, must hold/achieve a minimum score in an approved English language test as specified in Profile A of the <u>University's English Language Requirements Policy</u>.
