	Aims: to advance understanding of how the brain acquires and stores memory information, investigate the cellular processes that occur during learning, and how memory information is communicated between brain regions.	changes

	Benefits: improving the understanding of how learning and memory occurs in the healthy adult brain, which in turn will improve understanding of how learning and memory fails e.g. during ageing and in neurological and psychiatric disorders such as dementia, depression and schizophrenia.  Harms: rat and mouse research models. Some animals will either be bred with specific genetic alterations (no specific observable effects) or will undergo surgery involving either the implantation of indwelling cannulae (e.g. to enable drugs to be delivered directly into the brain), or neural probes (e.g. to stimulate specific neuronal networks). Thereafter, the performance of the animals will be assessed in a range of behavioural tasks to determine the effect of the manipulation on memory and learning.  Discussion:
