Of note it states: "The Royal Society's Fellowship and all those that receive grants from the Royal Society are expected to observe the highest standards of ethics and integrity in undertaking their research. Ethics and integrity are not an "optional extra" or a "regulatory burden" but an integral part of good research.

The Society considers it the responsibility of the Host Organisation to investigate and report all allegations of research misconduct and poor behaviour, and accepts that such investigations must be aligned to its internal human resources policies and disciplinary procedures.

Research misuse: The Society expects all award holders to observe the highest standards of ethics and integrity in undertaking their research.
