# **Application process**

## **Online application form**

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our <u>guidance for online applications page</u>

Applications will not be considered until **all** required documents have been uploaded.

$\checkmark$	References	We require one academic reference. References should comply with our standard requirements outlined on <u>our guidance pages</u> .
$\checkmark$	Degree certificate(s) and academic transcripts	From first and subsequent degrees. Degree certificates and transcripts should comply with our standard requirements outlined on <u>our guidance</u> <u>pages</u> .
$\checkmark$	Personal statement	Personal statements should highlight the motivation for applying for the course, and any relevant experience and/or skills.
$\checkmark$	English language certificates/other evidence	Evidence of meeting the English language profile as stated on the <u>Postgraduate Prospectus</u> and specified by the <u>University English</u> <u>Language Requirements Policy</u>
$\checkmark$	Curriculum Vitae (CV)	CVs might include details of other relevant work experience and qualifications to support an application.
$\checkmark$	Evidence of Numeracy	Evidence of numeracy skills is required. Please upload a certificate <b>in the</b> <b>'Other Information' section on the application form</b> to demonstrate how you meet this requirement (e.g. A-level Mathematics or Statistics- grade C or higher- or a module with a good mark in previous university degree, normally with a minimum of 60%/2:1 equivalent) (or UK

## **Selection process**

### Assessment of applications

All applicants are considered in line with the University's <u>Admissions Principles and Procedures Policy</u> Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Performance in undergraduate degree
- English language ability (where applicable)
- References
- Personal statement
- Evidence of Numeracy

#### Interviews

Interviews do not form part of the selection process.

The purpose of the interview is to assess whether the applicant has the necessary skills and capabilities to pursue the chosen postgraduate programme, and whether the programme is appropriate to the applicant's interests and aspirations.

If required, interviewees based overseas will normally be interviewed by telephone or Skype.

### Decisions

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

## Offer

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

## Deferrals

Deferrals are not permitted for this programme. Applicants are encouraged to re-submit their application for consideration the following year.

## **Results deadline**

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions by 29<sup>th</sup> July. Offer holders who will be unable to provide their final results by this date should email choosebristol-pg@bristol.ac.uk\_to notify the admissions team as soon as possible.

## **Additional information**

Extenuating circumstances

## Fees
