# **Postgraduate Admissions Statement for**



## **MSc Social Work**

# **Application process**

## Online application form

## **Selection process**

## **Assessment of applications**

All applicants are considered in line with the University's <u>Admissions Principles and Procedures Policy</u> Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Academic preparedness
- Good standard of written English
- Relevant learning from work and life experience
- Understanding of social care, social work and appropriate personal and intellectual qualities
- Understanding of, and commitment to, the values and ethics of social work.
- Written test and communication exercise administered by the school.

### **Interviews**

Shortlisted applicants will be invited for interview. The purpose of the interview is to assess whether the applicant has the necessary skills and capabilities to pursue the chosen postgraduate programme, and whether the programme is appropriate to the applicant's interests and aspirations. If required, interviewees based overseas will normally be interviewed by telephone or Skype.

## **Declaration of Suitability for Social Work**

Social Work England requires that the admissions processes assess the suitability of applicants to train as social workers, including their conduct, health and character. This process is referred to as a 'declaration of suitability for social work' and will need to be completed by all applicants shortlisted for interview.

## Decisions

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

#### Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met

#### Results deadline

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions by 29<sup>th</sup> July 2022. Offer holders who will be unable to provide their final results by this date should email <a href="mailto:choosebristol-pg@bristol.ac.uk">choosebristol-pg@bristol.ac.uk</a> to notify the admissions team as soon as possible.

#### **Deferrals**

Requests to defer the year of entry must be submitted via the applicant portal. Requests to defer should be submitted at the earliest opportunity so that it can be reviewed by the admissions team. We cannot guarantee that requests will be granted.

## **Disclosure and Barring Service**

A satisfactory criminal records disclosure will be required. Some programmes also require a check of the DBS Barred Lists prior to registration. Students from overseas or those who have lived overseas for a substantial period of time should provide a certificate of good standing or <u>appropriate alternative</u> <u>documentation</u> to meet this requirement.

## **Extenuating circumstances**

If your education has been significantly disrupted through health or personal problems, disability or specific difficulties within your studies, you can submit an <u>extenuating circumstances</u> form as part of your application.

The information provided will be treated confidentially and will help us to assess your academic performance fairly considering your circumstances.

## **Academic Technology Approval Scheme (ATAS)**

An ATAS certificate is not required for this programme.

### Visa

### **Deposits**
